Our Center includes a Library and Archives, as well as event and meeting spaces, an auditorium and multimedia theater.

Renamed the *Arizona Heritage Center at Papago Park* in 2015, it is one location of many under the Arizona Historical Society umbrella.

VOLUNTEER HOURS

Historical League members are asked to record their volunteer time. These volunteer hours are used by the museum staff to document the level of volunteer support when reporting to the state legislature, when applying for grants, and are required on the League tax return form.

Volunteer hours are acquired by hours served plus driving time. Overnight tours and bus tours receive a maximum credit of two hours per day. Social events also receive two hours credit unless a meeting is involved or volunteer work is performed.

BYLAWS OF HISTORICAL LEAGUE, INC.

ADOPTED DECEMBER 15, 1979

Last revised March 7, 2022 and last amended March 7, 2022

MISSION and GENERAL PROVISIONS

- 1.1 <u>Mission Statement</u>. The mission of the Historical League, Inc. (the "League") is to help preserve Arizona's multi-cultural heritage by promoting public understanding and appreciation of Arizona history.
- **1.2** Objectives: The League will accomplish its mission by:
- 1.2.1 Fundraising;
- **1.2.2** Contributing the services of its members;
- 1.2.3 Conducting educational and promotional activities; and
- 1.2.4 Supporting the Arizona Heritage Center at Papago Park, the Arizona Historical Society or other events, programs, and organizations with similar objectives and purposes.

MEMBERSHIP and MEMBERSHIP PRIVILEGES

- 2.1 Membership. An individual may join the League, by enrolling and paying the selected level of membership. The dues amount shall be determined by the membership upon recommendation of the Board of Directors. The membership year shall begin on July 1 and end on June 30 of the following year. Dues are payable at the beginning of the membership year and shall be delinquent on September 15. The membership directory shall be prepared in September for distribution to the membership in October.
- **2.2** Active Members. Active members are those persons who are current in annual dues and are active participants in volunteer services to the League.
- **2.3** <u>Associate Members</u>. Associate members are those persons who have paid the specified dues and are not expected to volunteer services to the League.
- 2.4 <u>Sustaining Members</u>. Sustaining members are those persons who have paid a one-time, specified fee for dues to last throughout their lifetime.
- **2.5** <u>Lifetime Members</u>. Lifetime members are those persons who have accumulated 5,000 service hours. A lifetime member is not required to pay dues.

MEMBERSHIP MEETINGS

- **3.1** General Membership Meetings. General Membership Meetings shall be held monthly September through June each year and at such other times as the President or two members of the Board of Directors shall call a meeting. Reasonable notice of each meeting shall be given to all members.
- **3.2** Referred Action Items. Action items referred from the Board of Directors to be voted on at a General Membership Meeting shall be on the agenda, presented in writing, and distributed to all members at least 72 hours before the meeting.
- 3.3 Annual Meeting of Members. Annual Meeting of Members shall be held during the month of May. The Board of Directors shall announce to the membership the date, time and place at least 30 days before the Annual Meeting of Members.
- 3.4 Special Meetings of Members. Special Meetings of Members shall be called by the President or two members of the Board of Directors. Written agenda notification as well as the meeting date and time, shall be disseminated to all members at least 10 days before the Special Meeting of Members.

- 3.5 <u>Voting.</u> Each member shall be entitled to cast one vote in person on any question put to a vote. There shall be no voting by proxy. All matters, unless otherwise provided by these Bylaws, shall be decided by a vote of the majority of members present at any meeting of the members.
- **3.6 Quorum.** A quorum shall consist of the number of members present at a meeting, provided that such number represents at least ten percent (10%) of the members.
- **3.7** Minutes. The minutes will be written by the Recording Secretary, approved by a majority of the membership at the next General Membership Meeting and kept on file in the League office.

BOARD OF DIRECTORS

SECTION 4

4.1 The Board of Directors Numbers and Terms. The Board of Directors shall be nine directors consisting of President, President-Elect, Recording Secretary, Treasurer, Advisor, and four at-large members. All directors shall serve one-year terms, and until their successors are duly elected and installed.

- 4.2 Board of Directors Meetings and Authority. The Board of Directors shall meet at least three times a year at times to be determined by the President. Additional meetings may be called by either the President or by the agreement of three other board members as may seem advisable. The Board of Directors shall manage and supervise the business and activities of the League in accord with the Articles of Incorporation and these Bylaws, and shall address all matters necessary to fulfill the mission of the League, including the power to create ad hoc or standing committees as may seem advisable. The President shall be chair. The Board of Directors may invite other members to attend any of their meetings.
- **Action.** Except as otherwise provided in these Bylaws, all matters decided by the Board of Directors shall require a majority vote of directors present at the meeting. The Board of Directors, may by majority vote, decide that an action is of such importance that it should be referred (with or without a recommendation from the board) for a vote by the members.
- **4.4** Quorum of the Board of Directors. A quorum shall consist of a majority of the directors then in office.
- **Minutes of the Board of Directors Meetings.** The minutes will be written by the Recording Secretary, approved by a majority the Board of Directors at the next meeting of the Board of Directors or by

- unanimous written consent, and kept on file in the league office. The President shall inform the members at the next General Membership Meeting of any action items voted on at a Board of Directors meeting.
- 4.6 Action by Directors without a Meeting. Any action required or permitted to be taken at a meeting of the Board of Directors or of any committee thereof may be taken without a meeting if a consent in writing, setting forth the action so taken, is signed by all directors then in office or committee members, as the case may be. Such consent may be executed in counterparts and shall have the same effect as a unanimous vote of the directors or committee members of the League at a duly convened meeting. The writing or writings evidencing such action taken without a meeting shall be filed with the Recording Secretary and inserted in the permanent records relating to meetings of the Board of Directors.

OFFICERS and DIRECTORS SECTION 5

5.1 <u>Designation of Officers</u>. The officers shall be President, President-Elect, Recording Secretary, and Treasurer.

- Election of Officers and Directors. Officers and Directors, other than the President and Advisor, shall be elected by the members at the Annual Meeting of Members. The President-Elect automatically assumes the office of President; and the Advisor is the immediate past-president. The installation of the incoming Board of Directors and officers shall take place at a General Membership Meeting following the Annual Meeting of Members held in May.
- **5.3** Terms of Officers. All officers shall serve one-year terms, and until their successors are duly elected and installed.
- 5.3 Vacancies. When a vacancy occurs, the Board of Directors shall fill the vacant position by a majority vote, either electronically or at the next scheduled meeting of the Board of Directors. The President-Elect shall automatically fill the vacant position of President until completion of term.
- **5.4** Removal. Any director or officer may be removed from office by a majority vote of the Board of Directors then in office whenever in the judgment of the directors the best interests of the League will be served by the removal.
- 5.5 Vacancies. When a vacancy occurs in the Board of Directors or in an officer position (except for the office of President), the Board of Directors shall fill the vacant position by a majority vote at the next scheduled meeting of the Board of Directors or by unanimous written consent. The President-Elect shall

- automatically fill the vacant position of President until completion of the term.
- 5.6 <u>President</u>. The President shall be the principal officer of the League, preside at General Membership Meetings, Board of Directors meetings, and Special Meetings of Members; serve as ex-officio member of all committees; perform duties normally associated with the office of President.
- **5.7 President-Elect.** The President-Elect shall perform such duties as determined by the President and Board of Directors, and assume the duties of the President in the absence of the President.
- 5.8 Recording Secretary. The Recording Secretary or /her designee shall, under the direction of the President, give notice of meetings and record and disseminate the minutes of the Board of Directors, General Membership Meetings, Annual Meeting of Members and any Special Meetings of Members. The Recording Secretary shall record Historical League Bylaws and Policy changes in the minutes.
- 5.9 <u>Treasurer</u>. The Treasurer or his/her designee shall, under the direction of the President, perform the duties normally associated with the office of Treasurer. The Treasurer shall ensure that all required corporate reports and tax returns are filed on a timely basis.

5.10 Advisor. The Advisor shall provide counsel to the Board of Directors and the President and serve as Parliamentarian. The Advisor shall serve as chair of the Nominating Committee and oversee an annual internal review of the League financial transactions.

COMMITTEES

- 6.1 Nominating Committee. The Nominating Committee shall be composed of Advisor, President, President-Elect and two (2) active members appointed by the President. Advisor shall serve as Chair. The committee shall nominate the members who will serve for the next membership year on the Board of Directors and as Chairs of the Standing Committees. Before the Annual Meeting of Members, the Board of Directors shall appoint the Chairs of the Standing Committees who will serve for the next membership year. The new Board of Directors, including the new officers, shall be elected by a vote of the members present at the Annual Meeting of Members.
- 6.2 Standing Committees. The Board of Directors shall establish, continue, or eliminate such Standing Committees as they determine advisable to carry out the mission of the Historical League. At the Annual Meeting of Members, the President shall introduce the Chairs of the Standing Committees who will serve for the following membership year. The Chair of each

Standing Committee shall report to the members at regular General Membership Meetings as often as the President considers advisable.

6.3 Ad Hoc Committees. There shall be Ad Hoc Committees as the Board of Directors shall deem necessary. The President shall appoint chair(s). Chair(s) shall appoint committee members.

AMENDMENTS

SECTION 7

7.1 Adoption of Amendments. Any amendment to the Bylaws shall require both an affirmative vote of twothirds of the members of the Board of Directors and an affirmative vote of two-thirds of the members present at a General Membership Meeting. After an affirmative vote by the Board of Directors, the Board shall provide written notice of the precise wording of the proposed amendment at the next General Membership Meeting, where such amendment shall be discussed but not voted upon. At the next General Membership Meeting, such amendment to the Bylaws may be adopted by an affirmative vote of two-thirds of the then serving members present at such meeting.

POLICY CHANGES

SECTION 8

8.1 Changes in Policies. Any changes to written League Policies must be consistent with these Bylaws and shall require an affirmative vote of a majority of both the Board of Directors and of the Members. After an affirmative vote by the Board of Directors, the Board shall provide written notice of the precise wording of the proposed changes in policies at the next General Membership Meeting, where such changes shall be discussed. At the next General Membership Meeting such policy changes may be adopted by an affirmative vote of a majority of the members present at such meeting.

FISCAL YEAR

SECTION 9

9.1 Fiscal Year. The fiscal year of the League shall be from July 1 to June 30 of the following year.

INDEMNIFICATION

SECTION 10

10.1 <u>Indemnification</u>. To the fullest extent permitted by Arizona law, every member of the Board of Directors, Officers, Committee members and/or agent(s) of the

League may be indemnified by the League against all expenses and liabilities, including counsel fees, reasonably incurred or imposed upon such members, in connection with any threatened, pending, or completed action, suit or proceeding to which that individual may become involved by reason of being or having been a member of the Board, Officer, Committee or agent of the League. The indemnification herein shall apply only when the Board of Directors approves such settlement and reimbursement as being in the best interest of the Historical League, Inc.
